The Contractor shall not leave windrows of snow at private driveways, sidewalk crossings, and fire hydrants.

Snow removal from the entrance and roadway for access to the Firehall will be included.

The Asquith Rink Parking Lot will be snowplowed as directed by the Town Foreman, CAO, or their representatives.

Snow piled in windrows shall be removed at the discretion of the Town Foreman, CAO, or their representative to address intersection safety and drainage concerns.

The Contractor will endeavor to minimize the height of the snowbanks at the intersections for safety reasons.

The Contractor is required to be available for work whenever requested by the Town Foreman, CAO, or their representative, including weekends and statutory holidays. He will be expected to commence operations within four hours of being contacted.

The Hours to be paid will be those hours in which the Contractor's equipment is actually employed in the activity of snowplowing. Hours resulting from transportation, breakdown, and other activities such as meal breaks, refueling, etc. are not to be charged to Town of Asquith.
